✦ RULES AND REGULATIONS

3. Admissions are made of the clear understanding that those who are admitted will fully accept the rules and regulations in force in the college or which may be framed from time to time not with standing that these rules are not incorporated in the University regulations or not prescribed by other colleges.
4. Admission made to the college are provisional subject to the approval of the University.
5. The Chaiman/Principal may refuse the admission to any student without giving reasons.
6. The college though not responsible for the conduct of its students outside its premises, will take cognizance of any serious misconduct of its students committed outside its premises.
7. Attendance at classes and examinations, progress as well as conduct of its students will be taken in to consideration while recommending students for merit certificates, concessions, scholarships, higher studies and employment.
8. Educational tours and excursions are to be organized with the permission of the Chairman / Principal. The parents will be informed of the date, place of the visit, route and the amount to be contributed. For all such programmes **written permission** of the parents is required.
